GENERAL PLAN INFORMATION

Cooling Off Period	10 business days
Contract Term	Ongoing with a 12 month benefit period. We'll notify you in advance if there are any changes to your benefits after the benefit period ends. If you don't hear from us, your benefits will remain unchanged.
Price Changes	Prices and fees may change, including the addition of new fees. We'll notify you in writing, which may be on your bill. If required, we'll give you at least 5 business days' notice; otherwise, we'll let you know no later than your next bill.
Standard Billing Cycle	105 days
Payment Methods	Monthly instalments via direct debit arrangement from your chosen bank account or credit/debit card. Each billing period, we may adjust your monthly instalment based on your expected gas use, using past usage data or seasonal trends if past data isn't available. We may also adjust your instalments to account for any difference between what you've paid and your actual gas use.

DISCOUNT AND PLAN INCENTIVES

Discount	The discounted price reflects a 25% conditional discount off our standard gas usage charges (applied after GST). This discount depends on you setting up and maintaining a monthly direct debit arrangement. If your direct debit fails for any reason (except for reasons attributable to us), we may remove the discount.
RAC Discount	Receive an extra 3% conditional discount off our standard gas usage charges (applied after GST). This discount depends on you entering a valid RAC membership number when signing up with Kleenheat. If you stop being an RAC member, the extra 3% discount will no longer apply. This discount cannot be used in conjunction with any other promotional discount.
Welcome Bonus	Choose one of the following welcome bonuses: a \$50 credit applied to your first bill, a \$50 Kmart gift card, a \$50 Target gift card, or 10,000 Flybuys bonus points, with gift cards and Flybuys points issued 90 days after your application is accepted.
Flybuys	1 Flybuys point for every \$1 (incl GST) billed and paid, provided you have linked your active Flybuys member number to your Kleenheat account.
OnePass	A one-year OnePass membership. A promocode to redeem the free one-year membership will be sent within 5 days of receipt of your Kleenheat sign-up application. OnePass membership will be charged at \$40 per year thereafter unless cancelled. This fee may change in accordance with the terms and conditions.

Interest on Overdue bills	3% above the one-month Bank Bill Swap Rate may be charged on arrears (calculated daily based on an annual percentage).

Australia Post Payment Fee	\$3.20 (incl GST) per payment made in person at a Post Office. Seniors over the age of 65 and customers in Kleenheat's financial hardship or vulnerable customer assistance programs are not charged this fee.
Paper Bill Fee	\$5.00 (incl GST) per paper bill mailed to you (no charge for email billing). You will not be charged for receiving paper bills if you are experiencing financial hardship or are identified as a vulnerable customer.
Bill Copy Fee	\$0.00 for the first request (up to 10 pages), then \$5.00 (incl GST) per bill copy thereafter.
Card Payment Fee	0.23% of the transaction amount for card payments, except for direct debit arrangements.
Dishonour Fee	\$10.00 for failed bank account direct debit or cheque payment.
